## Commitment to Achieving Net Zero

iMDsoft is committed to achieving the NHS's Net Zero emissions goals by 2050. As per the guidelines outlined in PPN 06/21, we understand that suppliers tendering for contracts with NHS England are mandated to submit a detailed CRP that includes our current carbon footprint, commitment to achieving Net Zero emissions by 2050, emissions reporting for Scope 1, Scope 2, and a subset of Scope 3 emissions, and environmental management measures.

## Carbon Reduction Plan in Response to PPN 06/21

To ensure that our carbon reduction plan meets the requirements set by PPN 06/21, we will be taking the following steps:

<b>Baseline Carbon Footprint Assessment</b>	We will begin by conducting a detailed evaluation of our current carbon footprint, focusing on Scope 1, Scope 2, and relevant Scope 3 emissions.
<b>Setting Net Zero Targets</b>	We will align our plan with the UK's Net Zero by 2050 goal and define clear, measurable reduction targets for emissions that are ambitious yet achievable, reflecting PPN 06/21's emphasis on significant environmental progress.
<b>Developing an Action Plan</b>	We will devise specific strategies tailored to our operations to meet the set targets, which may include investing in renewable energy sources, optimizing energy efficiency, or improving our organizational environmental behavior and adopting sustainable practices.
<b>Regular Monitoring and Adjustment</b>	We will establish a system for ongoing emissions monitoring to ensure that the plan remains responsive to changes within our business and stays on track to meet the targets set in the carbon reduction plan.
<b>Documentation and Transparency</b>	We will maintain comprehensive documentation of our strategies, targets, and progress, and ensure this information is accessible, preferably through publication on our company's website, demonstrating transparency and accountability as required by PPN 06/21.
<b>Annual Review and Reporting</b>	We will update our Carbon Management Plan annually to ensure compliance with PPN 06/21 and demonstrate our ongoing commitment to environmental responsibility. This regular review process will help us track progress and make necessary adjustments to achieve our set targets.

## Methods

The process will involve a comprehensive assessment of the organization's current carbon footprint, in order to identify major sources of emissions across various operations. As part of the process, we will set specific, measurable intermediate targets for reducing these emissions and outline practical steps to achieve these goals. The plan will serve our organization as a roadmap to minimize our environmental impact and move towards a more sustainable and environmentally responsible future.

While we are fully committed to complying with these requirements, we anticipate a delay of approximately 3 months in the submission of our CRP due to the comprehensive nature of the data collection and analysis required. We will complete the carbon footprint calculation within the next month and finalize the carbon reduction plan within the next 3 months. Rest assured, we are diligently working on gathering the necessary information and obtaining the necessary approvals to ensure that our plan meets the technical standards and reporting criteria specified in PPN 06/21.

Our team is actively engaged in the process of compiling accurate emissions data, outlining emission reduction strategies, and obtaining board approval for our CRP. We understand the importance of implementing such a process and are committed to delivering a thorough and transparent plan that reflects our dedication to sustainability and environmental stewardship.

Our efforts to create a carbon reduction plan aligned with the PPN 06/21 requirements are also in line with the environmental initiatives undertaken by our parent company, the Harris computers Operating Group, as outlined on their website (<https://csiesg.com/environment>).
